

ORDINANCE NO. 90-12

AN ORDINANCE OF THE CITY OF WEST MIAMI, FLORIDA, AMENDING SECTION 10-21, ARTICLE 11. NUISANCES, CHAPTER 10 OF THE WEST MIAMI CODE PROVIDING THAT SWIMMING POOLS THAT ARE NOT MAINTAINED IN A CLEAN AND SANITARY CONDITION FOR HUMAN USE OR ARE ALLOWED TO BECOME UNSAFE, DANGEROUS, UNHEALTHY OR AN ATTRACTIVE NUISANCE OR ARE ABANDONED, UNATTENDED, UNUSED OR ARE ALLOWED TO BECOME HABITATS OR PLACES FOR GROWTH OF INSECTS, BUGS, PESTS, BIRDS, FISH, SNAKES, REPTILES, VARMINTS, ANIMALS, PLANTS, WEEDS, GRASS, FUNGUS, GERMS, OR RODENTS, SHALL BE DEEMED A PUBLIC NUISANCE; PROVIDING FOR REPEAL OF ALL ORDINANCES OR PARTS THEREOF IN CONFLICT HEREWITH; PROVIDING FOR CODIFICATION; PROVIDING PENALTY; AND, PROVIDING AN EFFECTIVE DATE.

BE IT ENACTED BY THE CITY COMMISSION OF THE CITY OF WEST MIAMI, FLORIDA:

Section 1. That Sec. 10-21, Article 11. Nuisances, Chapter 10 of the West Miami Code be and is hereby amended to read as follows:

ARTICLE II. NUISANCES

Sec. 10-21. Defined.

The term "nuisance" as used herein shall include the following:


(a) Wrecked, abandoned or partially dismantled or otherwise inoperative automobiles, trucks, trailers, house trailers, boat trailers, boats and machinery of whatever nature which are unsightly and are in the open upon private or public premises within the limits of the city, unless stored in a completely enclosed garage or other completely enclosed building.

(b) Lawns, grass, weeds, shrubbery, hedges and other plants which have grown to an excessive height or are wild or

part of the West Miami Code; and that the sections of this ordinance may be renumbered or relettered and the word "ordinance" may be changed to "section, article" or such other appropriate word or phrase in order to accomplish such intentions.

Section 4. This Ordinance shall take effect immediately upon passage.
