

ORDINANCE NO. 331

ORDINANCE OF THE CITY OF WEST MIAMI
FLORIDA AMENDING SECTION 9-23 OF THE
WEST MIAMI CODE BY CHANGING FEES SET
FORTH THEREIN, FOR GARBAGE AND TRASH
COLLECTION; PROVIDING FOR FEE FOR
TRASH COLLECTION FROM MULTI-UNIT
RESIDENTIAL BUILDINGS: AND SETTING
EFFECTIVE DATE

BE IT ENACTED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF
WEST MIAMI, FLORIDA:

Section 1. That Section 9-23 of the Code of the
City of West Miami, Florida, be and is hereby amended to
read as follows:

"Sec. 9-23. Schedule of fees.

Subject to the provisions of section 9-24,
fees due and payable to the City for ser-
vices rendered in the collection and dis-
posal of garbage, trash and garden trash,
and/or for the availability of services
for the collection and disposal of garbage,
trash and garden trash, shall be as follows:

(a) Residential		
Two pickups per week		
(1) Single-family residence	\$25.00	\$50.00
(2) Duplexes-each unit	25.00	50.00
(3) Apartments, bed- room or efficiency- each unit	25.00	50.00
(b) Commercial and Industrial to include all rental property except those set forth in subsection (2) section 9-23.		
(1) Where trash only is accumulated and collected minimum per unit (and for first two trash con- tainers for one pick- up per week)	25.00	50.00
(2) Where trash only is accumulated and collected from multi-unit resident- tial buildings		

- (one pickup per week)
per unit (bedroom or
efficiency) 6.25 12.50
- (3) Where garbage, or gar-
bage and trash, is
accumulated and
collected, and for
first two garbage and/
or trash containers
for one pickup per
week. 25.00 50.00
- (4) Where additional
garbage, or trash,
or garbage and trash
is accumulated, re-
quiring containers in
excess of two, the
following charge per
pickup shall be levied
for each additional con-
tainer or the equivalent
in quantity:

\$.30 per 30-gallon container
\$2.10 per cubic yard

Where more than one pickup per
week is required, there shall
be levied an additional ser-
vice charge of \$2.00 per pickup."

Section 2. If any section or subsection of this
Ordinance is held invalid, the remainder of this ordinance
shall not be affected by such invalidity.

Section 3. It is the intent of the Council that
the provisions of this ordinance shall be a part of the Code
of the City of West Miami, Florida, and the sections of this
ordinance may be renumbered to accomplish such intention.

Section 4. The provisions of this ordinance shall
become effective January 1, 1973.
