

ORDINANCE NO. 341

AN ORDINANCE OF THE CITY OF WEST MIAMI, FLORIDA, APPROVING THE BUDGET FOR THE ENTITLEMENT PERIOD OF THE FEDERAL, STATE AND LOCAL FISCAL ASSISTANCE ACT OF 1972, COVERING THE PERIOD JULY 1, 1973, THROUGH AND INCLUDING JUNE 30, 1974, AND APPROPRIATIONS TO THE DIFFERENT DEPARTMENTS OF THE CITY, AND/OR AMOUNTS TO BE EXPENDED IN THE OPERATION OF SAID DEPARTMENTS, AND FOR OTHER ADMINISTRATIVE EXPENSES OF THE CITY.

BE IT ENACTED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF WEST MIAMI, FLORIDA:

Section 1. That effective this date, the budget of the funds of the entitlement period of the Federal, State and Local Fiscal Assistance Act of 1972, for the period July 1, 1973 through and including June 30, 1974, heretofore submitted to the City Council, which budget is as follows:




Section 2. In the interest of the general welfare of the residents of the City of West Miami, Florida, the second reading of this ordinance is waived.
