

ORDINANCE NO. 90-15

AN ORDINANCE OF THE CITY OF WEST MIAMI, FLORIDA, REPEALING ORDINANCE NO. 90-11 AND ESTABLISHING THE FINAL 1990 MILLAGE RATES UPON ALL REAL AND PERSONAL PROPERTY WITHIN THE CITY LIMITS FOR THE PAYMENT OF THE AMOUNTS APPROPRIATED IN THE PROPOSED 1990-1991 FINAL BUDGET; PROVIDING AN EFFECTIVE DATE AND PROVIDING THAT THE ORDINANCE NOT BE INCLUDED IN THE CODIFICATION OF ORDINANCES.

WHEREAS, the tentative proposed budgets of the City of West Miami, Florida, have been submitted; and

WHEREAS, the 1990 Real and Personal Property Tax Assessment Rolls of property within the City have been certified by the Metropolitan Dade County Property Appraiser, as provided in Section 200.065, Florida Statutes; and

WHEREAS, it is necessary to establish the final millage rates to produce the income in order to meet the requirements of the amended 1990-1991 final budgets as provided in Section 200.065, Florida Statutes; and

WHEREAS, it is necessary to repeal Ordinance No. 90-11 of the City of West Miami and enact this Ordinance:

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF WEST MIAMI, FLORIDA,

Section 1. Ordinance No. 90-11 of the City of West Miami be and is hereby repealed.

Section 2. In order to provide funds to cover all appropriations set forth in the FINAL 1990-1991 budgets of the City, there shall be and there is hereby levied upon the assessed valuation of all taxable real and personal property in the City of

West Miami, a tax of \$4.55 per each \$1,000.00 of assessed valuation as shown on the real and personal property assessment rolls for 1990 for the calendar year beginning January 1, 1990.

Section 3. In order to provide funds to cover all appropriations for the playground and recreation fund pursuant to Section 418.10, Fla.Stats., requiring annual levy and collection of a playground and recreation tax and as provided by subsection 11-2(b), Article 1 of Chapter 11 of the Code of the City of West Miami, there shall be and there is hereby levied upon the assessed valuation of all taxable real and personal property in the City of West Miami, a tax of \$1.00 per each \$1,000.00 of assessed valuation as shown on the real and personal property assessment rolls for 1990 for the calendar year beginning January 1, 1990.


Section 4. The said millage rate to be levied exceeds the roll-back rate by 7.56 percent, resulting in an increase in property taxes by said percentage.

Section 5. This ordinance shall take effect on October 1, 1990.

Section 6. This ordinance shall not be included the codification of the Code of Ordinance of the City.


