

ORDINANCE NO 91-06

ORDINANCE OF THE CITY OF WEST MIAMI, FLORIDA,
ESTABLISHING THE FINAL 1992 MILLAGE RATES
UPON ALL REAL AND PERSONAL PROPERTY WITHIN THE
CITY LIMITS FOR THE PAYMENT OF THE AMOUNTS
APPROPRIATED IN THE PROPOSED 1991-1992 FINAL
BUDGET; PROVIDING AN EFFECTIVE DATE AND PROVIDING
THAT THE ORDINANCE NOT BE INCLUDED IN THE
CODIFICATION OF ORDINANCES.

WHEREAS, the tentative proposed budgets of the City of
West Miami, Florida, have been submitted; and

WHEREAS, the 1992 Real and Personal Property Tax
Assessment Rolls of property within the City have been certified
by the Metropolitan Dade County Property Appraiser, as provided in
Section 200.065, Florida Statutes; and

WHEREAS, it is necessary to establish the final millage
rates to produce the income in order to meet the requirements of
the amended 1991-1992 final budgets as provided in Section
200.065, Florida Statutes;

NOW, THEREFORE, BE IT ENACTED BY THE CITY COMMISSION OF
THE CITY OF WEST MIAMI, FLORIDA,

Section 1. In order to provide funds to cover all
appropriations set forth in the FINAL 1991-1992 budgets of the
City, there shall be and there is hereby proposed to be levied
upon the assessed valuation of all taxable real and personal
property in the City of West Miami, a tax of \$ 5.65 per each
\$1,000.00 of assessed valuation as shown on the real and personal
property assessment rolls for 1992 for the calendar year beginning


January 1, 1992; and, as provided by subsection 11-2(b), Article 1 of Chapter 11 of the Code of the City of West Miami, there shall be and is hereby proposed to be levied thereupon a tax of \$1.00 per \$1,000.00 valuation as shown on the real and personal property assessment rolls for 1992 for the calendar year beginning January 1, 1992 for the playground and recreation fund established by said subsection of the Code of Ordinance of the City.

Section 2. The said millage rate to be levied exceeds the roll-back rate by 21.8% percent, resulting in an increase in property taxes by said percentage.

Section 3. This ordinance shall take effect on 9/25/91, 1991.

Section 4. This ordinance shall not be included the codification of the Code of Ordinance of the City.
