

ORDINANCE NO. 91-07

AN ORDINANCE OF THE CITY OF WEST MIAMI, FLORIDA, AMENDING SECTION 11-2, ARTICLE 1, CHAPTER 11 OF THE WEST MIAMI CODE BY ADDING SUBPARAGRAPH (d) PROVIDING FOR NON-RESIDENT ANNUAL FEES FOR THE USE OF THE RECREATION CENTER, 1700 S.W. 62 AVENUE, WEST MIAMI, OF \$40.00 FOR NON-RESIDENT, PAYABLE TO THE CITY OF WEST MIAMI, PROVIDING FOR A FAMILY DISCOUNT TO IMMEDIATE FAMILY MEMBERS AT THE RATE OF \$60.00 FOR TWO AND \$75.00 FOR THREE OR MORE FAMILY MEMBERS, PROVIDING FOR AN EFFECTIVE DATE.

BE IT ENACTED BY THE CITY COMMISSION OF THE CITY OF WEST MIAMI, FLORIDA,

Section 1. That Section 11-2, Article 1, Chapter 11 of the West Miami Code be amended to read as follows:

**Sec. 11-2. Supervised recreation system; establishment; tax; special fund; non-resident use fee.**

(a) All matters pertaining to the establishment, maintenance and conduct of a supervised recreation system for the City shall be planned, administered and supervised by the City Commission or by such person or persons as it may appoint to perform said duties according to law.

(b) In order to provide for the establishment, maintenance and conduct of a supervised recreation system, an annual levy of one (1) mill is hereby fixed upon all taxable property within the City limits; said tax to be designated as a playground and recreation tax, and the tax collector be, and he is hereby directed that commencing with the year 1953 and successive years, until repealed according to law, that he levy and collect

said taxes in the same manner as the general taxes of the City are collected.

(c) The proceeds of said tax be paid into a special fund to be designated as a playground and recreation fund, and to be used only for the purpose set forth in this section and as provided by law.

(d) Non-residents of the City shall pay the City an annual fee due on the 1st of October of each year for the use of the Recreation Center located at 1700 S.W. 62 Avenue, West Miami, as follows: Each person shall pay a fee of \$40.00, except that immediate family members residing in the same household shall pay a fee of \$60.00 for two members, and \$75.00 for three or more family members.

Section 2. This Ordinance shall take effect immediately upon passage.


