

ORDINANCE NO. 94-05

AN ORDINANCE OF THE CITY OF WEST MIAMI, FLORIDA, AMENDING ARTICLE I SECTION 10-11, PROVIDING FOR TEMPORARY POLITICAL SIGNS IN RESIDENTIAL DISTRICTS; NUMBER, SIZE AN LOCATION AND THE ESTABLISHMENT TEMPORARY POLITICAL SIGNS IN COMMERCIAL AREAS; PROHIBITIONS; NUMBER; SIZE; [REDACTED] LOCATIONS; PROVIDING FOR EFFECTIVE DATE; PROVIDING FOR CODIFICATION.

BE IT ENACTED BY THE CITY COMMISSION OF THE CITY OF WEST MIAMI, FLORIDA:

SEC.10-11. TEMPORARY POLITICAL SIGNS IN RESIDENTIAL DISTRICTS; NUMBER, SIZE AND LOCATION.

(a) No temporary political sign shall be allowed in any residential district within the City of West Miami except one temporary political sign shall be allowed on the premisses upon which the sign is displayed, which sign shall not exceed two (2) inches in height and three (3) inches in width and shall be placed no less than twenty-five (25) feet behind the front set back line of the property or adjacent to the main residential structure containing its front entrance, whichever is less. (Ord. No. 86-02, 1,4-2-86.

(b) No temporary political signs shall be allowed in any commercial area within the City of West Miami except that temporary political sign which shall be allowed in commercial premises upon which signs are displayed which shall not be more than 18 x 20 inches, located inside the plate glass window of each business facing the street.

All ordinances or parts of ordinances in conflict herewith be and the same are hereby repealed.

If any clause, section or other part of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, the remainder of this ordinance shall not be affected thereby, but shall remain in full force and effect.

This ordinance shall take effect on 21 day of SEPT., 1994.
