

ORDINANCE NO. 94-09

AN ORDINANCE OF THE CITY OF WEST MIAMI, FLORIDA, AMENDING ARTICLE IV, SECTION 3 OF ORDINANCE NUMBER 89-04, PROVIDING FOR DECREASE IN USER CHARGE RATE OF \$1.65 PER 100 CUBIC FEET OF WATER; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Dade County had increased its charges by twenty-five percent (25%) to the City of West Miami, for transmission and treatment of wastewater; and

WHEREAS, in order to maintain a self sufficient wastewater collection and transmission operation, the City is required to increase its users charge rate to \$2.00 per 100 cubic feet of water to its customers by reason of such increases charged by the County. However, said increase shall now be decreased to \$1.65 per cubic feet.

NOW, BE IT ENACTED BY THE CITY COMMISSION OF THE CITY OF WEST MIAMI, as follows:

Section 1: Section 3 of Article IV of ORDINANCE NO. 89-04 be amended to read as follows:

ARTICLE IV

Section 3. Each user shall pay a user charge rate for operation and maintenance, including replacement of \$1.65 per 100 cubic feet of water consumption.

Section 2. All ordinances or parts of the ordinances in conflict herewith be and the same are hereby repealed.

Section 3. If any clause, section, or other part of this Ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, the remainder of this Ordinance shall not be effected thereby, but shall remain in full force and effect.

Section 4. This Ordinance shall take effect immediately upon passage.
