

ORDINANCE No. 95-0 3

AN ORDINANCE OF THE CITY OF WEST MIAMI, FLORIDA, AMENDING CHAPTER 8, ARTICLE I BY ADDING SECTIONS 8-14; MAKING IT ILLEGAL TO DISPOSE OF GARBAGE AND OR TRASH IN MUNICIPAL PROPERTY; SETTING FORTH PENALTIES FOR VIOLATORS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ENACTED BY THE CITY COMMISSION OF THE CITY OF WEST MIAMI, FLORIDA:

SECTION I

CHAPTER 8, ARTICLE I OF THE CITY CODE SHALL BE AMENDED BY PROVIDING FOR ADDITIONAL SECTIONS AS FOLLOWS:

SECTION 8-14

It shall be unlawful to dispose or deposit trash or garbage upon any part of Municipal Property including but not limited to, City own or leased commercial dumpster, occupied or unoccupied premises within the city, or upon any street, alley, parkway or park, or in any canal, waterway, rock pit, pool or lake, within the city.

SECTION II

The City Manager through the Code Enforcement Officer is authorized to issue warnings and or to fine violators in the amount of ~~two~~ Hundred Dollars (~~\$200.00~~) for the first offense and (\$500.00) for each subsequent offenses.

SECTION III

All ordinances or parts of ordinances in conflict herewith be and the same are hereby repealed.

SECTION IV

If any clause, section or other part of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby, but shall remain in full force and effect.

SECTION V

It is the intention of the City Commission, and it is hereby ordained that the provisions of this ordinance shall become and be


made a part of the Code of Ordinances of the City of west Miami, Florida. The sections of this ordinance may be renumbered or relettered to accomplish such intention, and the word "ordinance" may be changed to "section," "article" or other appropriate word.

SECTION VI

This Ordinance shall take effect on 5 day of JULY, 1995.




