ORDINANCE NO. 98-02A

AN ORDINANCE AMENDING ARTICLE IV SECTION 2-69, "PURCHASES AND CONTRACTS" CODE OF ORDINANCES OF THE CITY OF WEST MIAMI BY ADDING SUBSECTION (c), ADOPTING COUNTY ORDINANCE 57-11 2, 9-16-58 ALLOWING JOINT PURCHASES BY COUNTY AND MUNICIPALITIES; SETTING EXEMPTION OF THE CITY OF WEST MIAMI FROM COMPETITIVE BIDDING; REPEALING ALL ORDINANCES INCONSISTENT HERewith; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE

BE IT ENACTED BY THE CITY COMMISSION OF THE CITY OF WEST MIAMI, FLORIDA as follows:

Section 1

Article IV - Purchases and Contracts, Section 2-68 shall be amended as follows:

Whenever the administrative department of the city desires to make a purchase of any equipment, supplies or material or to enter into any contract for services, labor and material, and the estimated purchase price or cost thereof is in excess of Five Hundred Dollars (\$500.00), but does not exceed ~~Seven Thousand Five Hundred Dollars (\$7,500.00)~~ ^{FIVE} Thousand ~~Five Hundred Dollars (\$5,000.00)~~, the city manager shall request quotations of prices for such proposed purchase or contract prior to final purchase or entry into such contract from those contractors and suppliers who have requested in writing that they be allowed to bid on such contracts or purchases.

Section 2

County Ordinance 64-41 and 1. 9-15-84 "Joint purchases by County and municipalities; exemption of municipality from competitive bid procedures" is hereby adopted.

Section 3

Article IV Section 2-69, Code of Ordinances of the City of West Miami shall be amended by adding subsection (c) to read as follows:

Sub Section (c) Joint purchases by County and the City of West Miami; exemption from competitive bid procedures.

Notwithstanding the above, wherever by an arrangement of the provisions in the contract documents of the County for the purchases of commodities by competitive bidding procedures, it is provided that the same price for which such commodities are available to the County, shall also, during the period of time provided therein be available

to the City of West Miami which may desire to purchase such commodities at the County contract price, then and in such event the purchase or purchases of such commodities under the provision of the County contract and at the County contract price shall be exempt from competitive bid requirements otherwise provided by this Code.

Sub Section (d)

Notwithstanding the above, the City Commission shall reserve the right to decide whether to require competitive bidding or avail itself of the provisions of the county, state or other approved GSA (Governmental) approved vendors/contracts for all purchases in excess of \$5,000.00.

This Ordinance, as amended, shall take effect, on 23 day of JUNE, 1998.
