

ORDINANCE # 98-04

AN ORDINANCE OF THE CITY OF WEST MIAMI, FLORIDA AMENDING CHAPTER 8, ARTICLE II SECTION 8-29 SETTING FORTH RESIDENTIAL GARBAGE FEES IN THE AMOUNT OF \$150.00 PER YEAR PER LIVING UNIT, PROVIDING FOR A 3 PAYMENT OPTION, PROVIDING FOR SEVERABILITY; PROVIDING FOR REPEAL OF ALL ORDINANCES OR PARTS THEREOF IN CONFLICT HEREWITH; PROVIDING FOR PENALTY; PROVIDING FOR CODIFICATION; AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ENACTED BY THE CITY COMMISSION OF THE CITY OF WEST MIAMI, FLORIDA:

SECTION I

CHAPTER 8, ARTICLE II SECTION 8-29 OF THE CITY CODE SHALL BE AMENDED AS FOLLOWS:

SECTION 8-29

Commencing the effective day of this Ordinance, an annual fee of one hundred dollars (\$150.00) is hereby assessed upon all residential living units within the City as defined in Section I of Ordinance 96-5. For the purpose of defraying the cost of waste collection and disposal, one-third (1/3) of said annual fee amount or fifty dollars (\$50.00) shall be due and collectible and payable quarterly and each succeeding year commencing as follows:

SECTION II

All ordinances or parts of ordinances in conflict herewith be and the same are hereby repealed.

SECTION III


