RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI ADOPTING THE 2015 LEGISLATIVE PRIORITIES FOR THE CITY OF WEST MIAMI; PROVIDING FOR EFFECTIVE DATE.

Whereas, the Mayor and City Commission of the City of West Miami have identified the 2015 Legislative Priorities; and

Whereas, The Mayor and City Commission wish to continue receiving funding from the State of Florida for the City's Community Center that serves our senior population so that we can continue providing congregate meals, home delivered meals, recreational activities, transportation services and nutrition screening and assessments to insure a healthy senior population; and

Whereas, the Mayor and City Commission requests recurring revenue to the West Miami in the amount of \$310,000.00 in an effort to continue promoting our Senior Center Activities for well over 250 seniors served every day; and

Whereas, The Mayor and City Commission of the City of West Miami are presently conducting a City wide study of the City's aged potable water system and have found huge leaks in that system and wish to address and promote water quality and adequate water quantity to our city residents,

Whereas, the Mayor and City Commission of the City of West Miami are requesting an amount of \$1,000,000.00 for the commencement of a multi-year water replacement program to address the replacement over time of the City's aged water system and corroded water lines; and

Whereas, The Mayor and City Commission of the City of West Miami urge the State of Florida Legislators to continue funding the City of West Miami Recreational Facilities with FRDAP programs that promote the concept of Leagues and Recreational programs for the youth in our community; and

Whereas, the City of West Miami has a current application with FRDAP in an amount of \$150,000.00 supported by a match for a roof overhang that would provide shelter and a more adequate structure over our basketball courts that will bring leagues and recreational participation to our Center.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI THAT:

Section 1. They adopt this list of above captioned priorities and commit to working with our State Representatives and the City's Legislative Consultant in an effort to preserve existing funding and new project funding.
