RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH D. CORPORATION CONSTRUCTION, INC. FOR THE AMOUNT OF EIGHTY THREE THOUSAND NINE HUNDRED TWENTY-EIGHT DOLLARS AND FIFTY CENTS (\$83,928.50) FOR THE PURPOSE OF ACCOMPLISHING THE FRENCH DRAIN INSTALLATION AND REPAIRS PROJECT; PROVIDING FOR FUNDING FROM PTP FUNDS; PROVIDING FOR EFFECTIVE DATE.

WHEREAS, the Mayor and City Commission of the City of West Miami, Florida desire to accomplish the French Drain Installation and Repairs Project; and

WHEREAS, the proposal submitted by D. Corporation Construction, Inc. in the amount of eighty three thousand nine hundred twenty-eight dollars and fifty cents has been found to be acceptable; and

WHEREAS, the locations of the proposed French drains are on 11th Street between 58th and 59th Avenues and 13th Street between 58th and 59th Avenues; and

WHEREAS, the City Manager and Public Works Director have recommended the above referenced bid award.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF WEST MIAMI THAT:

SECTION 1. The aforementioned statements are true and correct and adopted as is fully stated herein.

SECTION 2. The City Commission hereby authorizes the City Manager to accept the proposal from D. Corporation Construction, Inc. in the amount of eighty three thousand nine hundred twenty-eight dollars and fifty cents, pending the provisions of the City Code bid protest procedures.

SECTION 3. The funds to further the purposes described in the funding request shall be paid from PTP Funds.

SECTION 4. This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.
