



**RESOLUTION # 2015-11**

**RESOLUTION OF THE MAYOR AND THE CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO EXPEND A TOTAL OF THIRTY FOUR THOUSAND EIGHTY DOLLARS AND ZERO CENTS (\$34,080.00) IN CONNECTION WITH ENGINEERING AND CONSTRUCTION MANAGEMENT SERVICES TO BE PROVIDED BY T.Y. LIN INTERNATIONAL FOR THE LAP TRAFFIC CALMING DEVICES PROJECT; PROVIDING FOR FUNDING FROM PTP FUNDS; PROVIDING FOR EFFECTIVE DATE.**

**WHEREAS**, the Mayor and City Commission of the City of West Miami, Florida desire to accomplish the purpose outlined in the accompanying proposal; and

**WHEREAS**, the proposal for engineering and construction management services submitted by T.Y. Lin International in connection with the LAP Traffic Calming Devices project in the amount of thirty four thousand eighty dollars and zero cents (\$34,080.00) has been found to be acceptable; and

**WHEREAS**, the City Manager and Public Works Director have recommended the acceptance of the above referenced proposal.

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of West Miami as follows:

SECTION 1. The aforementioned statements are true and correct and adopted as is fully stated herein.

SECTION 2. The City Commission hereby authorizes the City Manager to accept the proposal of thirty four thousand eighty dollars and zero cents (\$34,080.00) from T.Y. Lin International to provide engineering and construction management services for the LAP Traffic Calming Devices project.

SECTION 3. The funds to further the purposes described in the funding request shall be paid from PTP Funds.

SECTION 4. This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.
