RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AMENDING RESOLUTION 2014-45 BY ESTABLISHING A FEE FOR GRANDPARENTS RESIDING IN THE CITY OF WEST MIAMI WHO HAVE CHILDREN LIVING OUTSIDE OF THE CITY OF WEST MIAMI WHO DESIRE TO ENROLL SAID GRANDCHILDREN IN THE AFTERSCHOOL CARE AND SUMMER CAMP PROGRAMS; AUTHORIZING THE PARK DIRECTOR OF THE CITY OF WEST MIAMI TO DETERMINE RESIDENCY AND KINSHIP FOR SAID GRANDPARENTS/GRANDCHILDREN; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Resolution 2014-45 establishes afterschool care and summer camp program fees for residents, non-residents and City employees whose children attend the programs offered by the City of West Miami Recreation Center; and

WHEREAS, the City Commission desires to establish a fee structure for grandparents residing in the City of West Miami who have grandchildren who live outside of the City of West Miami and wish to enroll those grandchildren in programs offered by the City of West Miami.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of West Miami as follows:

- Section 1. The aforementioned statements are true and correct and adopted as is fully stated herein.
- Section 2. Resolution 2014-45 shall remain in full force and effect as approved on August 20, 2014, except as provided herein.
- Section 3. Resolution 2014-45 shall be amended to add that Grandparents, residents of the City of West Miami, who have grandchildren who live outside of the City of West Miami may have them enrolled in the afterschool/summer camp program offered by the City of West Miami provided that the grandparents produce, to the satisfaction of the Park Director, documentation of residency in the City of West Miami and kinship relationship and that the grandchildren are enrolled in said program by their parent/legal guardian.
- Section 4. Grandparents who live in the City of West Miami who wish to have their grandchildren enrolled in the summer program who live outside of the City of West Miami pursuant to the requirements in Section 3, shall pay a fee of \$35.00 per week, per grandchild.

Section 5. Grandparents who live in the City of West Miami who wish to have their grandchildren enrolled in the afterschool care program who live outside of the City of West Miami, pursuant to the requirements in Section 3, shall pay a fee of \$45.00 per month, per grandchild.

Section 6. The Park Director of the City of West Miami has the authority to determine the residency and kinship of the grandparents/grandchildren. The City Manager shall have the ultimate authority to determine the decision of the Park Director.

Section 7. This Resolution shall become effective immediately upon passage. All Resolutions or parts of Resolutions in conflict herewith are repealed.


