A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE OFFICE OF THE CITY MANAGER THE SUM OF \$2,750.00 PAYABLE TO TYLIN INTERNATIONAL AS A LUMP SUM FEE FOR PROFESSIONAL SERVICES TO ENCOMPASS A RECONNAISSANCE OF THE EXISTING FACILITY AND NEIGHBORING PROPERTIES FOR EVIDENCE OF POTENTIAL ENVIRONMENTAL CONCERNS AND DATA TO SUPPORT KNOWN AS PHASE I ENVIRONMENTAL SITE ASSESSMENT PROPOSAL FOR THE PROPERTY LOCATED AT 1129 SW 66 AVENUE, WEST MIAMI, FLORIDA FOR THE APPLICATION MADE BY THE CITY OF WEST MIAMI IN CONNECTION WITH THE 2015-2016 CDBG FUNDING CYCLE; PROVIDING FOR FUNDING FROM PARKS IMPACT FEES; PROVIDING FOR EFFECTIVE DATE.

WHEREAS, the Mayor and City Commission of the City of West Miami, Florida desire to accomplish the purpose outlined in the accompanying proposal; and

WHEREAS, the proposal for Phase I Environmental Site Assessment (ESA) for the property located at 1129 SW 66th AVE, West Miami, FL 33144 submitted by T.Y Lin International in the amount of two thousand seven hundred fifty dollars and zero cents (\$2,750.00) has been found to be acceptable; and

WHEREAS, the City Manager and Public Works Director have recommended the acceptance of the above referenced proposal.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of West Miami as follows:

- SECTION 1. The aforementioned statements are true and correct and adopted as is fully stated herein.
- SECTION 2. The City Commission hereby authorizes the City Manager to accept the proposal of two thousand seven hundred fifty dollars and zero cents (\$2,750.00) from T.Y. Lin International to perform a Phase I Environmental Site Assessment (ESA) of the property located at 1129 SW 66th AVE, West Miami, FL 33144.
- SECTION 3. The funds to further the purposes described in the funding request shall be paid from Recreation Center Impact Fees.
- SECTION 4. This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.

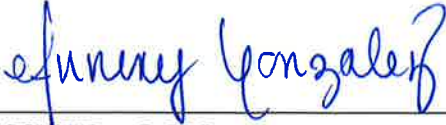
