RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI WAIVING COMPETITIVE BIDDING PURSUANT TO SECTION 2-74(A)(B), ARTICLE IV OF THE CODE OF THE CITY OF WEST MIAMI AS AN EMERGENCY AS A RESULT OF A FAILURE OF A PUMP AT LIFT STATION #3 LOCATED AT SYLVANIA BLVD AND SW 11 STREET; AUTHORIZING THE CITY MANAGER TO ENTER INTO AN EMERGENCY CONTRACT WITH HYDRA SERVICES INC. IN AN AMOUNT NOT TO EXCEED \$13,875.50 TO REPAIR SAID PUMP UNDER REPAIR QUOTE PUMPEX K107T-CA3307 TO BE PAID FROM PHASE II - SANITARY SEWER SYSTEM REPAIR ACCOUNT 237; PROVIDING FOR EFFECTIVE DATE.

WHEREAS, Sewer pump # 2 for Sewer Lift Station # 3 located on SW 11th Street and Sylvania Boulevard became out of service due to a mechanical damage; and

WHEREAS, in order to protect the health, safety and welfare of the citizens of the City of West Miami, the sewer pump needs to be repaired immediately; and

WHEREAS, the City has identified Hydra Service(s), Inc. as an adequate source to conduct the necessary repairs to the sewer pump for sewer lift station # 3; and

WHEREAS, the City Administration, in light of the emergency, secured local vendor quotes, finding that Hydra Services, Inc. was the best pricing for the repair.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF WEST MIAMI THAT:

Section 1. The aforementioned statements are true and correct and adopted as is fully stated herein.

Section 2. The City Commission waives the competitive bidding as a result of an emergency.

Section 3. The City Manager is hereby authorized to accept the above-mentioned proposal for repair services under repair quote Pumpex K107T-CA3307 in the amount of Thirteen Thousand Eight Hundred Seventy-five dollars and fifty cents (\$13,875.50) from Hydra Services Inc. to be financed from Phase II Sanitary Sewer Repair Account 237.

Section 4. The proposed work will include a complete overhaul of the sewer pump.

Section 5. This Resolution shall take effect immediately upon passage by the City Commission and signature by the Mayor.
