



RESOLUTION # 2015- 40

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONCESSION AGREEMENT WITH COMMUNITEL, INC. FOR THE PLACEMENT OF ONE (1) AUTOMATED TELLER MACHINE (ATM) IN THE LOBBY OF THE CITY OF WEST MIAMI; PROVIDING FOR EFFECTIVE DATE.

WHEREAS, many residents of the City of West Miami visit the City for the purpose of satisfying utility obligations; and

WHEREAS, many residents from outside of the City of West Miami visit the City for the purpose of using the U.S. passport services provided by the City; and

WHEREAS, a substantial amount of residents and visitors of the City of West Miami require the services of an Automated Teller Machine (ATM); and

WHEREAS, the City of West Miami is desirous to compliment said residents and visitors by allowing the installation of one (1) ATM in the lobby of City Hall; and

WHEREAS, Palm Beach County advertised for qualified entities to install, operate and maintain ATM's at the Palm Beach International Airport terminal; and

WHEREAS, Palm Beach County followed their own procurement requirements and have met the procurement requirements of West Miami; and

WHEREAS, Palm Beach County advertised a Notice for Request for Proposals, received proposals which were evaluated by a Selection Committee and recommended the selection of Communitel Inc. as the lowest, responsive, responsible bidder of RFP No. PB 14-5; and

WHEREAS, the City Commission finds that piggybacking to said procurement process is the proper instrument to provide desired services to the citizens of the City of West Miami and save tax payer dollars.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of West Miami as follows:

Section 1. The aforementioned statements are true and correct and adopted as is fully stated herein.

Section 2. The City Commission finds that piggybacking from Palm Beach County is cost and time effective.

Section 3. The City Manager is authorized to enter into a Concession Agreement with Communitel, Inc. under the terms and conditions set forth in their Concession Agreement with Palm Beach County. A copy of the Concession Agreement with Palm Beach County is attached hereto and made a part hereof as **Exhibit A**.

Section 4. This Resolution shall become effective immediately upon passage. All Resolutions or parts of Resolutions in conflict herewith are repealed.


