



RESOLUTION # 2015-68

RESOLUTION OF THE MAYOR AND THE CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER THE EXPENDITURE OF A TOTAL OF THIRTY ONE THOUSAND SIX HUNDRED FORTY-ONE DOLLARS AND FIFTY CENTS (\$31,641.50) IN CONNECTION WITH THE LANDSCAPING INSTALLATION AT ALL OF THE NEW TRAFFIC CIRCLES UNDER THE LAP AGREEMENT AND THE EXISTING TRAFFIC CIRCLES PAYABLE TO RICHWOOD LANDSCAPING; PROVIDING FOR FUNDING FROM PTP FUNDS; PROVIDING FOR EFFECTIVE DATE.

WHEREAS, the Mayor and City Commission of the City of West Miami, Florida desire to accomplish the purpose outlined in the accompanying proposal; and

WHEREAS, the proposal for installation of landscaping at the new traffic circles under the LAP Agreement and the existing traffic circles in the amount of thirty one thousand six hundred forty-one dollars and fifty cents (\$31,641.50) has been found to be acceptable; and

WHEREAS, the City Manager and Public Works Director have recommended the acceptance of the above referenced proposal.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of West Miami as follows:

- SECTION 1. The aforementioned statements are true and correct and adopted as is fully stated herein.
- SECTION 2. The City Commission hereby authorizes the City Manager to accept the proposal of thirty one thousand six hundred forty-one dollars and fifty cents (\$31,641.50) from Richwood Landscaping.
- SECTION 3. The funds to further the purposes described in the funding request shall be paid from PTP Funds.
- SECTION 4. This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.


