**RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO EXECUTE A THREE YEAR (3) YEAR CONTRACT WITH LOOK OUTDOOR MEDIA LLC FOR FY OCTOBER 1, 2016 FOR THREE FISCAL YEARS, WITH THE OPTION TO RENEW FOR THREE YEARS, PROVIDING FOR CPI INCREASE AT THE BEGINNING OF THE THIRD YEAR OF THE CONTRACT AS PUBLISHED BY THE DEPARTMENT OF LABOR, PROVIDING FOR PAYMENT BY THE CONTRACTOR TO THE CITY OF WEST MIAMI PROVIDING FOR ADVERTISEMENT OPPORTUNITY FOR THE CITY AT NO COST TO THE CITY, PROVIDING FOR EFFECTIVE DATE.**

**WHEREAS**, the Mayor and City Commission of the City of West Miami, Florida desire to accomplish the purpose outlined in the accompanying Agreement.

**NOW, THEREFORE, BE IT RESOLVED:**

**SECTION 1.** The City Commission hereby authorizes the City Manager to enter into an Agreement with Look Advertising LLC. for a period of three (3) years, with year one commencing on October 1<sup>st</sup>, 2016 with an end date of September 30<sup>th</sup>, 2019, and the Contractor will pay a City a flat fee of \$500.00 per month, per the attached contract. The Contractor, shall have the option to renew for three years, and contract executed no later than sixty (60) days prior to the expiration of the term, and each option will be subject to a rate based on the CPI index.

**SECTION 2.** This Resolution shall take effect immediately upon adoption.
