



RESOLUTION # 2017-17

RESOLUTION OF THE MAYOR AND THE CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO EXPEND A TOTAL OF NINE THOUSAND EIGHT HUNDRED FIFTY-SIX DOLLARS (\$9,856.00) FOR SERVICES IN CONNECTION WITH PROFESSIONAL DESIGN DOCUMENTS TO UPGRADE EXISTING LOBBY RESTROOMS TO UNISEX AND ONE ADA COMPLIANT AND REPLACEMENT OF A/C UNIT FOR CITY HALL AND PROVIDE A/C TO RESTROOMS AND STAIRWELL; PAYABLE TO SCEC; PROVIDING FOR EFFECTIVE DATE.

WHEREAS, the Mayor and City Commission of the City of West Miami, Florida desire to accomplish the purpose outlined in the accompanying proposal; and

WHEREAS, the proposal for designing services in the amount of nine thousand eight hundred fifty-six dollars (\$9,856.00) has been found to be acceptable; and

WHEREAS, the City Manager and Planning and Zoning Director have recommended the acceptance of the above referenced proposal.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of West Miami as follows:

SECTION 1. The City Commission hereby authorizes the City Manager to accept the proposal of nine thousand eight hundred fifty-six dollars (\$9,856.00) in connection with the design documents to upgrade existing lobby restrooms to unisex and one ada compliant and replacement of a/c unit for city hall and provide a/c to restrooms and stairwell.

SECTION 2. The funds to further the purposes described in the funding request shall be paid from the City National Bank loan.

SECTION 3. This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.


