



RESOLUTION # 2017-26

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO ACCEPT THE PROPOSAL FROM FOR THE PURCHASE OF TWO (2) GAZEBOS, 20' IN SIZE AS PART OF THE GARDEN CLUB PARK EXPANSION PROJECT FOR A PRICE OF FORTY FOUR THOUSAND ONE HUNDRED DOLLARS (\$44,100.00) TO INCLUDE THE PURCHASE OF THE GAZEBOS AND THE LABOR INVOLVED IN THE CONSTRUCTION, WAIVING THE NEED FOR COMPETITIVE BIDDING, RECOGNIZING THE VENDOR AS A REGISTERED STATE OF FLORIDA VENDOR WHO TRANSACTS BUSINESS WITH OTHER CITIES THUS ALLOWING THE CITY OF WEST MIAMI TO BENEFIT FROM GOVERNMENT CONTRACT PRICING, PROVIDING 100% OF COST TO BE PAID FROM CITY OF WEST MIAMI RECREATION CENTER IMPACT FEES, PROVIDING FOR EFFECTIVE DATE.

WHEREAS, the Mayor and City Commission of the City of West Miami, Florida desire to accomplish the purpose outlined in the accompanying proposal; and

WHEREAS, the proposal for two (2) 20' gazebos as part of the Garden Club Park; and

WHEREAS, the City Manager and Planning and Zoning Director have recommended the acceptance of the above referenced proposal.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of West Miami as follows:

SECTION 1. The City Commission hereby authorizes the City Manager to accept the proposal of forty-four thousand one hundred dollars (\$44,100.00) in connection with the construction of two gazebos at the Garden Club Park.

SECTION 2. The funds to further the purposes described in the funding request shall be paid from the Park Impact Fees.

SECTION 3. This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.
