



**RESOLUTION # 2017-27**

**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO ACCEPT THE PROPOSAL FROM MIRACLE RECREATION EQUIPMENT CO. FOR THE PURCHASE OF (2) PLAYGROUND EQUIPMENT AGE APPROPRIATE FOR THE CITY OF WEST MIAMI GARDEN CLUB PARK EXPANSION PROJECT FOR AN AMOUNT OF ONE HUNDRED TWENTY-ONE THOUSAND ONE HUNDRED FORTY-FIVE DOLLARS AND SIXTY-EIGHT CENTS (\$121,145.68), TO BE PAID FROM THE CITY OF WEST MIAMI IMPACT FEE FUNDS, WAIVING THE COMPETITIVE BID REQUIREMENT PROVIDING FOR 100% OF COST TO BE PAID FROM THE CITY OF WEST MIAMI RECREATION IMPACT FEES, PROVIDING FOR EFFECTIVE DATE.**

**WHEREAS**, the Mayor and City Commission of the City of West Miami, Florida desire to accomplish the purpose outlined in the accompanying proposal; and

**WHEREAS**, the proposal for two (2) age appropriate playground equipments as part of the Garden Club Park; and

**WHEREAS**, the City Manager and Planning and Zoning Director have recommended the acceptance of the above referenced proposal.

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of West Miami as follows:

**SECTION 1.** The City Commission hereby authorizes the City Manager to accept the proposal of one hundred twenty-one thousand one hundred forty-five dollars and sixty-eight cents (\$121,145.68) in connection with the construction of two playground equipment at the Garden Club Park.

**SECTION 2.** The funds to further the purposes described in the funding request shall be paid from the Park Impact Fees.

**SECTION 3.** This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.
