



RESOLUTION # 2017-31

RESOLUTION OF THE CITY OF WEST MIAMI, FLORIDA ESTABLISHING THE 2017 TENTATIVE MILLAGE RATES UPON ALL REAL AND PERSONAL PROPERTY WITHIN THE CITY LIMITS FOR THE PAYMENT OF THE AMOUNTS APPROPRIATED IN THE 2017-2018 PRELIMINARY BUDGET.

WHEREAS, The 2016 Real and Personal Property Tax assessment rolls of property within the City have been certified by the Metropolitan Dade County Property Appraiser as provided in F.S. 200.065; and

WHEREAS, The Final budgets of the City of West Miami, Florida, have been submitted; and

WHEREAS, It is necessary to establish the Tentative Millage Rate to produce the income in order to meet the requirements of the 2017-2018 budgets as provided in F.S. 200.065;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF WEST MIAMI, FLORIDA:

Section 1. The aforementioned statements are true and correct and adopted as is fully stated herein.

Section 2. In order to provide funds to cover all appropriations set forth in the 2016-2017 Final budget of the City, there shall be and there is hereby proposed to be levied upon the assessed valuation of all taxable real and personal property in the City of West Miami, a tax of \$5.8858 per each \$1,000.00 of assessed valuation as shown on the real and personal property assessment rolls for 2016 for the calendar year beginning January 1st, 2018; and, as provided by Ordinance 133 as codified in sub-section 11-2 of the West Miami Code, and there is hereby proposed to levy thereupon a tax of \$1.00 per \$1,000.00 valuation for the playground and Recreation Fund established by said Ordinance. **For a total combined millage rate of \$6.8858.**

Section 3. The said millage rate to be levied increases the roll back rate by 15.34 % percent, resulting in an increase in property taxes by said percentage. Current year rollback rate 5.9698. Adopted millage rate 6.8858.

Section 4. This Resolution shall take effect immediately upon passage by the City Commission and signature by the Mayor.
