RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO EXECUTE A TWO YEAR CONTRACT BETWEEN THE CITY OF WEST MIAMI AND DR. LOURDES MARTINEZ, M.S.R.D.L.D. REGISTERED INDEPENDENT DIETICIAN TO THE WEST MIAMI COMMUNITY CENTER PROGRAM, PROVIDING FOR A TWO YEAR CONTRACT COMMENCING OCTOBER 1, 2017 THROUGH SEPTEMBER 30, 2019 AT A RATE OF \$65.00 PER HOUR, SAID FUNDS TO BE BUDGETED IN THE CITY OF WEST MIAMI COMMUNITY CENTER BUDGET FOR THE DURATION OF THE CONTRACT WITH THE CONDITION THAT HER SERVICE TO THE CENTER KEEPS WITH THE MANDATES OF THE ALLIANCE FOR AGING AND THE DEPARTMENT OF ELDER AFFAIRS; PROVIDING FOR EFFECTIVE DATE.

Whereas, The Mayor and City Commission of the City of West Miami hereby authorize the City Manager to execute a Contract between the City of West Miami and Dietitian Lourdes I. Martinez for Nutrition Services to the West Miami Community Center as required by the Alliance for Aging, in the amount of sixty five dollars (\$65.00) per hour and at least five (5) hours monthly, and

Whereas, The Mayor and City Commission have acted on a recommendation by the City Manager to approve such a contract.

Now, Therefore, Be It Resolved that the Mayor and City Commission of the City of West Miami authorize the City Manager to execute a Contract between the City of West Miami and Dietitian Lourdes I. Martinez for Nutrition Services to the West Miami Community Center as required by the Alliance for Aging, in the amount of sixty five dollars (\$65.00) for year two 2017-2019.


