**RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO PURCHASE TWO POLICE CRUISERS FROM HUB CITY FORD UNDER THE FLORIDA SHERIFF'S ASSOCIATION BID, TO BE PAID 100% FROM POLICE IMPACT FEES FOR A TOTAL OF SEVENTY-THREE THOUSAND EIGHT HUNDRED EIGHTEEN DOLLARS AND TWENTY-ONE CENTS \$ 73,818.21 TO INCLUDE PURCHASE COSTS, INSTALLATION AND PURCHASE OF EMERGENCY EQUIPMENT AND STRIPPING, PROVIDING FOR EFFECTIVE DATE.**

**WHEREAS**, the West Miami Police Department needs to replace two patrol units; and

**WHEREAS**, the safety of the citizens of the City of West Miami greatly benefits by the constant patrol of police vehicles; and

**WHEREAS**, HUB City Ford has submitted an estimate of \$55,950.00 for two police cruisers, Signal Technology Enterprises, Inc. and Graphics Designs International have also submitted estimates to outfit and mark these vehicles for a grand total of \$ 73,818.21.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF WEST MIAMI THAT:**

**Section 1.** The aforementioned statements are true and correct and adopted as is fully stated herein

**Section 2.** The City Commission finds that the purpose of two new vehicles to replace worn down patrol cars constituted a priority for the City of West Miami.

**Section 3.** That piggy-backing from another agency will be advantageous for the City because of price, terms and conditions of a completely solicited contract from another public agency.

**Section 4.** The City Manager is hereby authorized to purchase two vehicles for a total amount not to exceed \$73,818.21 to be funded by Police Impact Fees.

**Section 5.** This Resolution shall take effect immediately upon passage by the City Commission and signature by the Mayor.


