



RESOLUTION # 2017-52

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO TRANSFER CONFERENCE AND TRAINING DOLLARS ALLOCATED IN THE CITY COMMISSION BUDGET FOR FISCAL YEAR 2017-2018 AND INCREASE THE MAYOR'S ALLOCATION BY \$1,000.00 AND INCREASE THE VICE-MAYOR'S ALLOCATION AS WELL AS THE THREE MEMBERS OF THE CITY COMMISSION BY AN AMOUNT OF \$750.00 EACH, PROVIDING FOR THE FUNDS TO BE USED FOR THE DIRECT BENEFIT OF THE CITY OF WEST MIAMI, PROVIDING FOR AUTHORIZATION/SAID APPROVAL TO BE ISSUED BY THE OFFICE OF THE CITY MANAGER, PROVIDING FOR INSTRUCTIONS TO THE CITY MANAGER TO MAINTAIN THE LEVEL OF FUNDS FOR UPCOMING BUDGET YEARS, TO BE REVIEWED ON A YEARLY BASIS, PROVIDING FOR EFFECTIVE DATE.

Whereas, the Mayor and City Commission authorized an amount of \$4,000 in the 2017-2018 City Budget in the City Commission Division identified as Training and Conference, and

Whereas, the Mayor and City Commission at a Regular City Commission Meeting held on Wednesday, October 18th, 2017 discussed the parameters/guidelines for the use of the \$4,000 by its' members, and

Whereas, the Mayor and City Commission of the City of West Miami after discussion and clarifications made a determination to divide the \$4,000 as herein specified for the 2017-2018 Fiscal Year and have instructed the Manager to budget accordingly under the representation accounts in future budget years as follows:

MAYOR:	\$3,400 REPRESENTATION ACCOUNT
VICE-MAYOR	\$2,750 REPRESENTATION ACCOUNT
COMMISSIONERS:	\$2,750 REPRESENTATION ACCOUNT FOR THREE COMMISSIONERS (EACH OF THEM RECEIVING AN ALLOCATION OF \$2,750)

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI that:

Section 1. The City Manager is hereby authorized to transfer conference and training dollars allocated for fiscal year 2017-2018 as follows:

Mayor:	\$ 1,000.00
Vice-Mayor and Three Commissioners:	\$750.00 each.

Section 2. The funds described in Section 1 shall be paid from the City of West Miami City Commission Training and Conference Account.

Section 3. This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.
