



RESOLUTION # 2018-04

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO ACCEPT THE PROPOSAL FROM MIRACLE RECREATION EQUIPMENT CO. FOR THE PURCHASE OF A SHADE STRUCTURE AS PART OF THE GARDEN CLUB PARK EXPANSION PROJECT FOR THE PRICE OF FOURTEEN THOUSAND TWENTY DOLLARS(\$ 14,020.00) TO INCLUDE THE PURCHASE OF THE SHADE STRUCTURE AND THE LABOR INVOLVED IN THE CONSTRUCTION, WAIVING THE NEED FOR COMPETITIVE BIDDING; PROVIDING 100% OF COST TO BE PAID FROM CITY OF WEST MIAMI PARK IMPACT FEES, PROVIDING FOR EFFECTIVE DATE.

WHEREAS, the Mayor and City Commission of the City of West Miami, Florida desire to accomplish the purpose outlined in the accompanying proposal; and

WHEREAS, the proposal for a square shade structure measuring 23' X 23' X 12'; submitted by Miracle Recreation Equipment, Co. totals \$ 14,020.00 and

WHEREAS, the City Manager and Planning and Zoning Director have recommended the acceptance of the above referenced proposal.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of West Miami as follows:

SECTION 1. The City Commission hereby authorizes the City Manager to accept the proposal of fourteen thousand twenty dollars (\$ 14,020.00) in connection with the construction of a square shade structure at Garden Club Park.

SECTION 2. The funds to further the purposes described in the funding request shall be paid from the Park Impact Fees.

SECTION 3. This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.


