



**RESOLUTION # 2018-07**

**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO ACCEPT THE PROPOSAL FROM MIRACLE RECREATION EQUIPMENT FOR THE PURCHASE OF THE MOTOR POOL EQUIPMENT FOR THE NEW PUBLIC SERVICES BUILDING FOR THE AMOUNT OF FORTY-SEVEN THOUSAND EIGHT HUNDRED EIGHTY DOLLARS AND EIGHTY CENTS (\$ 47,880.80); PROVIDING 100% OF COST TO BE PAID FROM CITY OF WEST MIAMI POLICE AND SEWER IMPACT FEES, PROVIDING FOR EFFECTIVE DATE.**

**WHEREAS**, the Mayor and City Commission of the City of West Miami, Florida desire to accomplish the purpose outlined in the accompanying proposal; and

**WHEREAS**, the proposal for new equipment at the motor pool area in the amount of forty-seven thousand eight hundred eighty dollars and eighty cents has been found acceptable ; and

**WHEREAS**, the City Manager and Planning and Zoning Director have recommended the acceptance of the above referenced proposal.

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of West Miami as follows:

**SECTION 1.** The City Commission hereby authorizes the City Manager to accept the proposal of forty seven thousand eight hundred eighty dollars and eighty cents in connection with the purchase of the motor pool equipment at the new Public Services building.

**SECTION 2.** The funds to further the purposes described in the funding request shall be paid from Police and Sewer Impact Fees.

**SECTION 3.** This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.
