RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI RESCINDING RESOLUTION # 2017-36 PASSED AND ADOPTED ON AUGUST 16TH, 2017 AND ADOPTING A NEW RESOLUTION TO COMPLY WITH THE TERMS AND CONDITIONS OF FRDAP CONTRACT NUMBER A017071, AUTHORIZING THE CITY MANAGER TO ACCEPT A PROPOSAL IN THE AMOUNT OF FIFTY-TWO THOUSAND NINE HUNDRED FORTY-THREE DOLLARS AND EIGHTY-TWO CENTS (\$ 52,943.82) FROM MIRACLE RECREATION EQUIPMENT CO. FOR THE PURCHASE OF NEW PLAYGROUND EQUIPMENT FOR EDMUND P. COOPER PARK FUNDED BY THE 2016-2017 FRDAP GRANT IN THE AMOUNT OF \$35,000 WITH A MATCH FROM PARK IMPACT FEES IN THE AMOUNT OF \$18,000 THE CITY OF WEST MIAMI PARK IMPACT FEES FOR A TOTAL OF \$ 52,943.82; PROVIDING FOR EFFECTIVE DATE, PROVIDING FOR SEVERABILITY.

WHEREAS, the Mayor and City Commission of the City of West Miami, Florida adopted Resolution # 2017-36 on August 16th, 2017 for the purchase of new playground equipment to be installed at the northeast corner of Cooper Park ; and

WHEREAS, FRDAP Contract Number A17071 DEP Contract Number A017071 was executed by the City of West Miami on February 2nd, 2018; and

WHEREAS, The City of West Miami had received Quote Number 23170047 in the amount of \$ 52,943.82 and desire to accomplish the purpose outlined in the accompanying proposal; and

WHEREAS, the proposal for one (1) age appropriate playground equipment as part of the Edmund P. Cooper Park for the amount of \$52,943.82 from Miracle Recreation Equipment Co. has been found acceptable; and

WHEREAS, the City Manager and Planning and Zoning Director have recommended the acceptance of the above referenced proposal.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of West Miami as follows:

SECTION 1. The City Commission hereby authorizes the City Manager to accept the proposal of fifty-two thousand nine hundred forty-three dollars and eighty two cents (\$52,943.82) in connection with the installation of one playground equipment at Edmund P. Cooper Park.

SECTION 2. The funds to further the purposes described in the funding request shall be funded by the 2016-2017 FRDAP Grant in the amount of \$ 35,000.00 with a match from Park Impact Fees in the amount of \$ 18,000.00 for a total of \$ 52,943.82.

SECTION 3. This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.

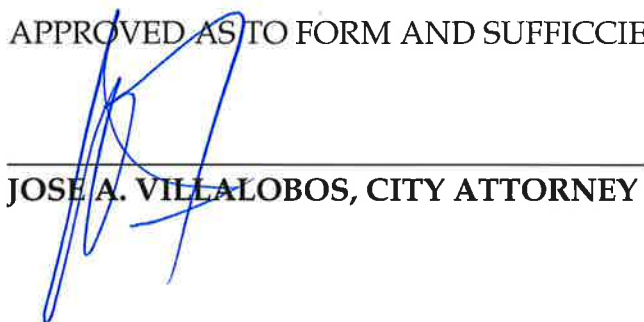
