RESOLUTION OF THE MAYOR AND THE CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO EXECUTE A SUBSCRIPTION AGREEMENT BETWEEN FLORIDA PACE FUNDING AGENCY AND CITY OF WEST MIAMI FOR THE PURPOSE OF PROVIDING THE PROPERTY OWNERS OF THE CITY OF WEST MIAMI THE OPPORTUNITY TO PARTICIPATE IN THE STATE OF FLORIDA APPROVED PACE PROGRAM PURSUANT TO CITY RESOLUTION # 2017-04 FOR ENERGY EFFICIENT PROPERTY IMPROVEMENTS; PROVIDING FOR EFFECTIVE DATE; PROVIDING FOR SEVERABILITY AND INSTRUCTING THE CITY CLERK TO TRANSMIT THIS RESOLUTION TO THE PROPERTY APPRAISER AND TO THE MIAMI DADE TAX COLLECTOR'S OFFICE.

WHEREAS, the Mayor and City Commission of the City of West Miami, Florida desire to accomplish the purpose outlined in the accompanying Subscription Agreement; and

WHEREAS, the City of West Miami desires to facilitate financing of qualifying improvements for properties located within the City of West Miami area , as further defined and detailed herein, the City of West Miami and the Florida Pace Funding Agency, hereby agree that the City of West Miami approve that certain agreement attached hereto and made a part hereof as Exhibit A, together with only those rights and obligations of Parties to the Agreement as are necessary to fulfill this Subscription Agreement.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of West Miami as follows:

SECTION 1. The aforementioned statements are true and correct and adopted as is fully stated herein.

SECTION 2. The City Commission hereby authorizes the City Manager to execute the Subscription Agreement between Florida Pace Funding Agency and the City of West Miami.

SECTION 3. This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.


