



**RESOLUTION # 2018-42**

**RESOLUTION OF THE MAYOR AND THE CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO EXECUTE AN INTERLOCAL AGREEMENT BETWEEN MIAMI-DADE COUNTY WATER AND SEWER DEPARTMENT AND CITY OF WEST MIAMI; PROVIDING FOR SEWER DISPOSAL SERVICE BY ALLOWING THE CONNECTION OF THE CITY'S SEWAGE COLLECTION SYSTEMS TO THE COUNTY'S SEWAGE TRANSMISSION FACILITIES AT PUMP STATION # 120 LOCATED AT SW 8<sup>TH</sup> STREET /65<sup>TH</sup> AVE AND PUMP STATION # 121 LOCATED AT SW 20<sup>TH</sup> STREET / 67<sup>TH</sup> AVE; PROVIDING THAT THE CONTRACT SHALL BE AND REMAIN IN FULL FORCE AND EFFECT FOR A PERIOD OF TWENTY (20) YEARS FROM THE EFFECTIVE DATE OF THE CONTRACT; PROVIDING FOR EFFECTIVE DATE.**

**WHEREAS**, on February 18, 1986, the COUNTY and the CITY entered into a contract to provide sewage disposal services by the COUNTY to the CITY (the "1986 Contract"); and

**WHEREAS**, on March 30, 1993, the COUNTY and the CITY entered into Addendum Number One to the 1986 Contract, which incorporated the second phase of a sewage collection system to serve the City; and

**WHEREAS**, on September 13, 1994, the COUNTY and the CITY entered into Addendum Number Two to the 1986 Contract that provided a modification to the payment of sewer connection charges; and

**WHEREAS**, the COUNTY and the CITY desire to enter into this Interlocal Contract (the "Contract") so the COUNTY can continue to render sewage disposal service to the CITY; and

**WHEREAS**, the Miami-Dade Water and Sewer Department, hereinafter referred to as the "Department", operates and maintains the COUNTY'S sewage disposal system.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AS FOLLOWS:**

**SECTION 1.** The aforementioned statements are true and correct and adopted as is fully stated herein.

**SECTION 2.** The City Manager is hereby authorized to execute the Interlocal Agreement by and between Miami-Dade County and the City of West Miami for sewage disposal services.

**SECTION 3.** This Resolution shall become effective immediately upon passage. All Resolutions or parts of Resolutions in conflict herewith are repealed.
