



## **RESOLUTION # 2018-43**

**RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER THE EXPENDITURE OF SIXTEEN THOUSAND THREE HUNDRED FIFTY DOLLARS (\$16,350.00) FOR THE PURPOSE OF ACCOMPLISHING THE CLEANING AND PAINTING WITH BITUMINOUS PAINT THE PIPING AND WALLS AT LIFT STATIONS # 1, 2 AND 3; PROVIDING FOR EFFECTIVE DATE.**

**WHEREAS**, the Mayor and City Commission of the City of West Miami, Florida desire to accomplish the cleaning and painting with bituminous paint the piping and walls at Lift Stations # 1, 2 and 3 ; and

**WHEREAS**, the proposal submitted by Desmar Plumbing Contractors in the amount of sixteen thousand three hundred fifty dollars (\$ 16,350.00) has been found to be acceptable; and

**WHEREAS**, the Acting City Manager has recommended the approval of the above referenced proposal.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF WEST MIAMI THAT:**

**SECTION 1.** The aforementioned statements are true and correct and adopted as is fully stated herein.

**SECTION 2.** The City Commission hereby authorizes the Acting City Manager to accept the proposal from Desmar Plumbing Contractors in the amount of sixteen thousand three hundred fifty dollars (\$ 16,350.00)

**SECTION 3.** The funds to further the purposes described in the funding request shall be paid from impact fees.

**SECTION 4.** This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.


