



RESOLUTION # 2018-60

RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH SUMMER SYSTEMS IN THE AMOUNT OF \$ 10,000.00 TO RENEW A CONTRACT EXECUTED BY AND BETWEEN THE CITY OF WEST MIAMI AND SUMMER SYSTEMS ON OCTOBER 2014 TO CONTINUE SERVING HARDWARE AND SOFTWARE ON EQUIPMENT INSTALLED IN WEST MIAMI POLICE DEPARTMENT POLICE PATROL AUTOMOBILES FROM FUNDS DERIVED FROM DEPARTMENT OF JUSTICE EQUITABLE SHARING RESULTING FROM FUNDS CONFISCATED IN JOINT DRUG INVESTIGATIONS.

WHEREAS, police officers throughout the country rely on swift instant and accurate communications in order to protect the health, safety and welfare of citizens at large; and

WHEREAS, it essential for police officers to have access to the best communication possible for swift response to emergencies, crime control, accidents and other unexpected occurrences; and

WHEREAS, the City of West Miami has been recognized as one of the fastest and efficient police departments in the entire country; and

WHEREAS, in order to continue their excellent community work, the City of West Miami requires continuous maintenance and upgrading of its communication facilities; and

WHEREAS, the City of West Miami switched the computerized reporting system by installing laptop computers in officer police automobiles; and

WHEREAS, the City of West Miami entered into an agreement with Summer Systems to install and maintain a very complex and sophisticated communications systems in our police cruisers; and

WHEREAS, the City Administrator, after comprehensive review of sources available has determined that it would be extremely time consuming and expensive to dispense the services of Summer Systems at this time; and

WHEREAS, in concurrence with the Chief of Police, the administrators recommend to renew our present contract and/or supply and services with Summer Systems.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF WEST MIAMI AS FOLLOWS:

SECTION 1. The aforementioned statements are true and correct and adopted as is fully stated herein.

SECTION 2. The Manager of the City of West Miami accepts the recommendation of the Manager and the Chief of Police and authorizes the Manager to enter into an extension of the agreement existing with Summer Systems.


SECTION 3. The Mayor and the City Commission authorizes the City Manager to execute the Agreement attached herein in the amount of \$ 10,000.00.

SECTION 4. Said funds shall be paid from funds derived from the Department of Justice Equitable sharing resulting from the confiscated funds in joint drug investigations.
