RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE ACTING CITY MANAGER TO EXECUTE THE NECESSARY DOCUMENTATION WITH TY LIN INTERNATIONAL FOR PREPARATION AND CONSTRUCTION INSPECTION SERVICES FOR BATHROOM CONSTRUCTION AND PASSPORT OFFICE EXPANSION AT THE CITY OF WEST MIAMI IN THE AMOUNT OF \$21,472.00 TO BE FUNDED BY IMPACT FEES; PROVIDING FOR EFFECTIVE DATE.

WHEREAS, the City of West Miami's Passport Office is in need of expansion and renovation to its bathroom facilities; and

WHEREAS, the City Manager has recommended that this work is necessary due to the growing demand of passport services at the City of West Miami; and

WHEREAS, Ty Lin, International (Consultants) will prepare the bid documents for the City of West Miami Passport Office addition and restroom renovations and construction engineering inspection (CEI) services pursuant to the attached Exhibit A; and

WHEREAS, this service is within the Professional Engineering Services Agreement entered into by and between the City of West Miami and TY Lin International on April 18, 2018; and

WHEREAS, the cost of the services to be provided by TY Lin International is \$21,472.00.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF WEST MIAMI THAT:

SECTION 1. The aforementioned statements are true and correct and adopted as is fully stated herein.

SECTION 2. The City Manager's recommendation is hereby accepted and the City Manager is hereby authorized to enter into an agreement with TY Lin International in the amount of \$21,472.00 for services more fully described in the attached Exhibit A.

SECTION 3. Funding for the work to be provided by TY Lin International pursuant to Exhibit A shall come from Impact Fees.

SECTION 4. This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.
