RESOLUTION OF THE MAYOR AND THE CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER THE EXPENDITURE OF TEN THOUSAND DOLLARS (\$10,000.00) FROM PARK IMPACT FEES TO BE USED AS A MATCH FOR RIGHT-OF-WAY TREES WITH THE MIAMI-DADE COUNTY NEAT STREETS MIAMI MATCHING GRANT; PROVIDING FOR EFFECTIVE DATE.

WHEREAS, the Mayor and City Commission of the City of West Miami (the "City") would like to accomplish the application for a grant with matching grant in the amount of \$10,000 from the Miami-Dade County Neat Streets Miami Board (the "Grant"); and

WHEREAS, the City wishes to use grant funds to replace urban tree canopy that was lost within City's right-of-way during the last hurricane season (the "Project"); and

WHEREAS, staff recommends that the City Commission authorize the City Manager to accept a matching grant in the amount of \$10,000 from the Miami-Dade County Neat Street Miami Board;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Grant Acceptance. The Grant from the Miami-Dade County Neat Streets Miami Board in the amount of \$10,000.00 is approved and accepted. The City Manager is authorized to accept the Grant.

Section 3. Authorization. The City Manager is authorized to accept the grant funding, transfer funds in order to fund the project, execute associated agreements with Miami-Dade County Neat Streets Miami, Inc. and SFM Services, Inc., and expend budgeted funds from Park Impact Fees on behalf of the City in an not to exceed amount of \$10,000 in furtherance of the Project.

Section 5. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to achieve the intended purpose.
