



**RESOLUTION # 2020-14**

**RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI WAIVING COMPETITIVE BIDDING AS PROVIDED IN SECTION 2-74(a)(b) ARTICLE IV OF THE CITY CODE OF THE CITY OF WEST MIAMI AND AUTHORIZING THE CITY MANAGER TO PIGGY-BACK OFF THE ORANGE COUNTY, A POLITICAL SUBDIVISION OF THE STATE OF FLORIDA, THEIR AGREEMENT WITH HYDRA SERVICE/ABS PUMPS (EXHIBIT A) IN LIEU OF THE CITY OF WEST MIAMI'S COMPETITIVE BIDDING PROCEDURE; ACCEPTING A BID THAT HAS BEEN RECEIVED (EXHIBIT B) FOR THE PURPOSE OF REPLACING AND INSTALLING TWO SEWER PUMPS AT THE LIFT STATION OF SW 66<sup>TH</sup> AVE AND SW 20<sup>TH</sup> ST, KNOWN AS LIFT STATION # 2 THAT HAS FAILED; PROVIDING FOR FUNDING FOR SAID PUMP FROM THE SEWER IMPACT FEE FUND; PROVIDING FOR TERMS AND CONDITIONS FOR SAID PURCHASE CONTRACT; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the existing sewer lift pumps have long past the life expectancy of service of said pumps; and

**WHEREAS**, the City of West Miami has suffered consistent failures in the pump systems; and

**WHEREAS**, replacement of these pumps is in the best interest of the City in order to protect the health, safety and welfare of the citizens of the City of West Miami; and

**WHEREAS**, City Administration has verbally requested quotes from companies having similar services and equipment and has found it to be in the best interest of the City of West Miami to accept a quote from Hydra Service/Abs Pumps as the best and most economical contract for the City; and

**WHEREAS**, Orange County has conducted a procurement process and has contracted with Hydra Service/Abs Pumps for a similar project as needed in the City of West Miami and repairs for the pump for the lift station in question; and

**WHEREAS**, the Mayor and City Commission have accepted the recommendation of Administration to contract the services of Hydra Service/Abs Pumps for the replacement and installation of said pump.

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of West Miami as follows:

**Section 1.** The foregoing "whereas" clauses and heading are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption thereof.

**Section 2.** The City of West Miami hereby waives the competitive bidding requirement pursuant to Section 2-74 (a)(b) of the Code of the City of West Miami.

**Section 3.** The City Manager is authorized to piggy-back on that certain contract by and between Orange County and Hydra Service/Abs Pumps (See Exhibit A) and accept the bid for the replacement and installation of a pump at the Lift Station at Sylvania Boulevard. See Exhibit B.

**Section 4.** The City Manager is authorized to enter into a contract on behalf of the City with Hydra Service/Abs Pumps for the purchase and installation of the said pump in the amount of \$ 47,736.00.

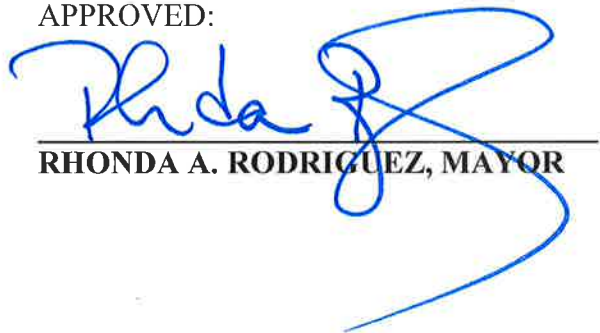
**Section 5.** The funds to further the purpose of the funding request shall be taken from the Sewer Phase I Account # 580-600 Sewer Fund.

**Section 6.** If any clause, section, or other part or application of this Resolution shall be held by any court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid part or application shall be considered as eliminated and so not affecting the validity of the remaining portions or applications remaining in full force and effect.

**Section 7.** This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.
