



RESOLUTION # 2020-22

RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH MCCOURT CONSTRUCTION FOR THE PURPOSE OF RESURFACING (2) TENNIS COURTS AND (2) BASKETBALL COURTS LOCATED IN THE CITY OF WEST MIAMI RECREATION CENTER FOR AN AMOUNT OF FIFTY EIGHT THOUSAND SIX HUNDRED DOLLARS (\$58,600.00) TO BE FUNDED PARTIALLY BY THE STATE OF FLORIDA, LWCF GRANT, LAND AND WATER CONSERVATION FUND GRANT PROGRAM AND 50% MATCH FROM THE CITY OF WEST MIAMI PARK IMPACT FEES BUDGETED FOR 2019-2020 FISCAL YEAR UNDER LINE ITEM #572-602, PROVIDING FOR EFFECTIVE DATE.

WHEREAS, the City of West Miami advertised for a bid request under bid number 202006032020 requesting qualified bidders to provide their proposals for the basketball resurfacing and acrylic repainting of the Recreation Center; and

WHEREAS, only two (2) firms submitted responses to the bid; and

WHEREAS, on June 3rd, 2020, the bids were opened and McCourt Construction, Inc. was deemed the lowest responsive, responsible bidder with its bid in the amount of \$58,600.00.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of West Miami as follows:

Section 1. The aforementioned statements are true and correct and adopted as is fully stated herein.

Section 2. The City Mayor and City Commission hereby authorize the City Manager to enter into a contract with McCourt Construction, Inc. in the amount of \$58,600.00 for basketball resurfacing and acrylic repainting of the Recreation Center pursuant to the terms and conditions set forth in the Agreement attached hereto as **Exhibit "A."**

Section 3. This contract amount is to be funded partially by the State of Florida Land and Water Conservation Fund Grant Program and 50% match from the City of West Miami Park Impact Fees budgeted for 2019-2020 Fiscal Year under line item # 572-602.

Section 4. This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.
