



RESOLUTION # 2020-60

RESOLUTION OF THE MAYOR AND THE CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO ENTER INTO AN INTERLOCAL AGREEMENT BETWEEN MIAMI-DADE COUNTY AND ALL FIRST RESPONDER AGENCIES OPERATING IN MIAMI-DADE COUNTY FOR DIRECT RADIO COMMUNICATION BETWEEN 911 PUBLIC SAFETY ANSWERING POINTS AND FIRST RESPONDER AGENCIES; PROVIDING FOR SEVERABILITY; PROVIDING FOR EFFECTIVE DATE.

WHEREAS, Section 365.179 F.S., requires that each sheriff, in collaboration with all first responder agencies facilitate the development and execution of interlocal agreements establishing protocols of communication between public service agencies and first responder agencies; and

WHEREAS, said protocol facilitates communication between Public Safety Answering Points (PSAP) and local agencies to assure prompt communication between First Responder Agency and 911 services; and

WHEREAS, enhanced communications between First Responder Agency to any emergency, ensures the healthy, safety and welfare of all citizens.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of West Miami as follows:

Section 1. The aforementioned statements are true and correct and adopted as is fully stated herein.

Section 2. The City Commission hereby authorizes the City Manager to execute an Interlocal Agreement between Miami-Dade County and the City of West Miami as First Responder Agency pursuant to the Interlocal Agreement attached herein as Exhibit A.


Section 3. This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.
