**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI, FLORIDA; RELATING TO GRANTS; APPROVING A FLORIDA RECREATIONAL DEVELOPMENT ASSISTANCE PROGRAM (FRDAP) GRANT IN THE AMOUNT OF FIFTY-THOUSAND (\$50,000) DOLLARS FOR COOPER PARK EXERCISE EQUIPMENT; AUTHORIZING THE CITY MANAGER TO EXECUTE THE GRANT AGREEMENT (NO. A24068) BETWEEN THE CITY OF WEST MIAMI AND THE FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION (FDEP), AND OTHER GRANT RELATED DOCUMENTS AS REQUIRED; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of West Miami previously submitted a grant application to the Florida Department of Environmental Protection (FDEP) requesting assistance from the Florida Recreational Development Assistance Program (FRDAP) to help fund needed improvements to Cooper Parks outdoor exercise area; and

**WHEREAS**, the City Commission adopted Resolution NO. 2022-53 authorizing the submission of said application; and

**WHEREAS**, the project has been identified as a Capital Improvement project (CIP) for Fiscal Year (FY) 23/24 for the City (Attachment B); and

**WHEREAS**, the City was successful in securing grant funding in the amount of fifty-thousand (\$50,000) dollars with no match required; and

**WHEREAS**, the City desires to move forward with the acceptance of the DEP Agreement No. A4068/Project No. A24068.

**NOW, THEREFORE BE IT RESOLVED** by the City Commission of the City of West Miami as follows:

**THE ABOVE WHEREAS' ARE ADOPTED HEREIN AS PART OF THIS RESOLUTION.**

Section 1: The City Commission hereby accepts the grant award from the Florida Department of Environmental Protection's Recreational Development Assistance Program in the amount of fifty-thousand (\$50,000) dollars.

Section 2: The City Manager is hereby authorized to sign the required grant agreement in substantial form and content to the attachment A, and other related documents.

Section 3: The resolution shall take effect immediately upon its adopting.
