A RESOLUTION OF MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI, FLORIDA; RELATING TO PROCUREMENT, APPROVING CONTRACTOR SELECTION OF SUPERIOR LANDSCAPING & LAWN SERVICE, INC. AS THE LOWEST RESPONSIVE RESPONSIBLE BIDDER; PURSUANT TO ITB# 2024-20-001 SHADING WEST MIAMI 2024 – TREE PLANTING – INVITATION TO BID FOR TREE PLANTING SERVICES RELATED TO GRANT AWARDED BY NEAT STREETS MIAMI'S GREEN MATCHING GRANT PROGRAM; AUTHORIZING THE CITY MANAGER TO ENTER INTO CONTRACT IN THE AMOUNT OF ONE HUNDRED TWENTY FOUR THOUSAND FOUR HUNDRED TWENTY-ONE DOLLARS AND SIXTY CENTS (\$124,421.60) FOR THE CITY-WIDE PLANTING OF TREES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, it is the desire of the City to plant trees to increase green spaces, shading for public walkways, provide shelter to wildlife, and increase oxygen; and

WHEREAS, the City was successful in securing funding from the Miami-Dade County Neat Streets Matching Grant Program to plant trees; and

WHEREAS, the Commission approved and accepted the grant agreement at the February 28, 2024 meeting via Resolution No. 2024-11; and

WHEREAS, the City advertised for procurement of planting and watering services on January 24, 2024 and closed the procurement process on February 8, 2024; and

WHEREAS, Staff selected the lowest responsive responsible bidder from the three (3) received proposals; and

WHEREAS, the City desires to name Superior Landscaping & Lawn Service, Inc. as the lowest responsive responsible bidder and enter into contract.

NOW, THEREFORE BE IT RESOLVED by the City Commission of the City of West Miami as follows:

THE ABOVE WHEREAS' ARE ADOPTED HEREIN AS PART OF THIS RESOLUTION.

Section 1: The City Commission approves the selection of Superior Landscaping & Lawn Service, Inc. as the lowest responsive responsible bidder to be selected as the contractor for the GREEN tree planting project.

Section 2: The City Manager is hereby authorized to execute a contract with Superior Landscaping & Lawn Service, Inc. for the completion of city-wide tree planting project.

Section 3: The resolution shall take effect immediately upon approval.
