



RESOLUTION # 2024-23

RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO ACCEPT A MITIGATION OFFER IN THE AMOUNT OF THREE THOUSAND FIVE HUNDRED DOLLARS (\$3,500.00) FROM ISMAEL DE MARCHENA ON CODE ENFORCEMENT LIENS FOR CODE VIOLATIONS AT THE PROPERTY LOCATED AT 6377 SW 14 ST, WEST MIAMI, FL; PROVIDING THAT IF PAYMENT IN FULL IS NOT PAID BY MAY 3RD, 2024, THEN THE AMOUNT OWED SHALL REVERT TO THE ORIGINAL LIEN AMOUNT; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Code Enforcement liens for code violation has been levied against the property located at 6377 SW 14 ST, West Miami, Florida under **Case # CE 2023-456** in the amount of \$6,490.50, **Case # CE 2023-457** in the amount of \$6,490.50, **Case # CE2023-458** in the amount of \$6,457.50, **Case # CE 2023-456** in the amount of \$1,000.50, **Case # CE 2022-447** in the amount of \$1,000.50 totaling \$ 21,472.50; and

WHEREAS, the Mayor and City Commission have received a negotiated settlement offer in the amount of Three Thousand Five Hundred Dollars (\$3,500.00).

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AS FOLLOWS:

SECTION 1. The aforementioned statements are true and correct and adopted as is fully stated herein.

SECTION 2. The City Manager is hereby authorized to accept the mitigation offer in the amount of Three Thousand Five Hundred Dollars (\$3,500.00) to settle Code Enforcement liens for code violations at 6377 SW 14 ST, West Miami, Florida under **Case # CE 2023-456** in the amount of \$6,490.50, **Case # CE 2023-457** in the amount of \$6,490.50, **Case # CE2023-458** in the amount of \$6,457.50, **Case # CE 2023-456** in the amount of \$1,000.50, **Case # CE 2022-447** in the amount of \$1,000.50 totaling \$ 21,472.50 and subsequently release said liens.

SECTION 3. This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor
